## **Disaster management**

World Physiotherapy recognises that disasters/emergencies resulting from human, natural, environmental and technological hazards (includes biological, geological, hydrometeorological and socio-natural hazards) have a major and long-lasting impact on people and the countries in which they live.

World Physiotherapy encourages member organisations to facilitate the contribution of physiotherapists, as experts in physiotherapy intervention/treatment including rehabilitation, to national and local disaster preparedness and management strategies.(1) Physiotherapists should:

- be involved in the process of developing policies and plans that help areas, countries and regions prepare for disasters/emergencies
- be involved in preventive education and measures before, during and after disasters/emergencies
- provide interventions/treatment, including rehabilitation to those affected by disasters/emergencies
- ensure that populations affected have access to physiotherapy intervention/treatment, including rehabilitation services to achieve the highest attainable level of health and function

World Physiotherapy encourages member organisations to:

- work with national governments, non-governmental organisations (NGOs), aid agencies and others to develop disaster/emergency prevention plans, preparedness and response strategies, and provision of coordinated responses to situations
- facilitate discussion, share resources and provide guidance to individual physiotherapists wishing to respond/volunteer in emergency relief situations
- encourage professional entry level physical therapy programmes to include disaster/emergency management in their curricula
