




of AMC respondents have **increased** their membership during the last year.

PHYSIOTHERAPISTS PER 10,000 POPULATION IN THE REGION








Of the 41 AMC respondents in the region, **12** reported a higher percentage of female **board members** than the percentage of female physiotherapists in the workforce in their country/territory.




17% of countries/territories have **full direct access** to physiotherapy services in the region. This is the lowest level across all five regions.

54% of the AMC respondents reported direct access only for **private physiotherapy** services.

29% reported direct access is **not allowed**.

The most frequently reported **limitation to direct access** was **practice setting** (51%).





SPAIN - MEMBERSHIP GROWTH

The Spanish Physiotherapy Association (AEF) **increased their membership by 18%** during 2022, continuing a trend of membership growth since 2016. Their strategies to increase membership include:

- agreements with universities so physiotherapist educators are offered a discount on the AEF membership fee
- creation of six new interest groups (subgroups) to expand areas of clinical interest within the profession, bringing the total to 14 AEF subgroups
- organisation of scientific and training events throughout Spain, decentralising them from the AEF offices in Madrid
- agreements with regional professional associations (regulators)
- promotional campaigns to attract new members
- new subgroup for students, diversifying pathways to membership
- strengthening presence on social media to highlight AEF activities.





EUROPE CASE STUDY



SPAIN - LEADERSHIP AND GENDER

In AEF there is a balance in gender between the physiotherapy workforce and representation within the AEF executive board. Women represent 62% in both the workforce and executive board. Their strategies to increase female representation in leadership roles include:

- leveraging the historically high participation of women in executive roles
- intentional work towards gender balance in leadership roles
- campaigns and internal processes to promote women in decision-making roles of subgroups, diversifying participation and inclusion.

- The AMC was sent to 125 member organisations, of which 116 responded, representing a 92.8% response rate. This is consistent with previous years' response rates and demonstrates strong engagement between World Physiotherapy and its member organisations. The census date was 30 June 2022.
