Relationship with other health professionals

Physiotherapists practise in partnership with other health professionals to manage and provide services to patients/clients.

World Physiotherapy expects physiotherapists to have an understanding of the role and function of the other professions, appreciating core differences as well as common features.

It is the responsibility of World Physiotherapy's member organisations, as well as individual physiotherapists, to have strategies in place so that the roles and functions of physiotherapists and the efficacy of physiotherapy services can be demonstrated and marketed to other health professions.

As stated in World Physiotherapy's policy on direct access, World Physiotherapy believes that "physiotherapy professional entry level education prepares physiotherapists to be first contact autonomous practitioners, able to examine/assess, evaluate, diagnose, prognose, intervene/treat, determine outcomes and discharge patients/clients without referral from another health professional (eg medical practitioner) or other third party." (1, 2)Where a medical referral is required to initiate physiotherapy services, the referral should contain essential medical/health information and an indication to examine/assess and intervene/treat. Physiotherapists may also accept referrals from other professionals.

Physiotherapists are qualified to undertake a comprehensive examination/assessment of the patient/client to formulate a diagnosis and plan of care, to implement a therapeutic intervention/treatment programme if appropriate, to evaluate the outcome of any intervention/treatment, and to determine discharge arrangements.(3, 4) In doing so physiotherapists practise with other health professionals to act in the best interests of their patients/clients.

World Physiotherapy encourages its member organisations to raise awareness and educate other professions of the scope of physiotherapist practice in order to enhance inter-professional collaborative practice and to benefit patients/clients.

Physiotherapists should have policies and procedures in place to ensure communication with their patients'/clients' medical practitioners and other relevant professionals. These policies and procedures will facilitate consultation and accurate documentation and reports by physiotherapists to other service delivery providers. (5, 6)
