Percentage of physiotherapists who are members of a World Physiotherapy member organisation in the South America region compared with total physiotherapy workforce




Since 2020, the percentage of physiotherapists who are members of a World Physiotherapy member organisation in the **South America region** compared with the total workforce did **not** decrease










NUMBER OF ENTRY LEVEL EDUCATION PROGRAMMES PER 5,000,000 POPULATION



#### MOST FREQUENTLY REPORTED LIMITATIONS TO DIRECT ACCESS IN SOUTH AMERICA



**42%** Setting (eg outpatient, private practice, school setting, prevention and wellness, etc)



**25%** Population/health condition (eg musculoskeletal, non-complex, etc)



**8%** Time (eg medical referral required if treatment is needed beyond 30 or 60 days)



Training (eg certification, academic training, or
CPD to demonstrate skill necessary to treat patients without referral from a medical doctor)



**33%** Payment (eg certain payers will not pay for services delivered via direct access)

# CASE STUDY COLOMBIA: INVOLVEMENT WITH SPECIAL INTEREST GROUPS

In September 2024 the Asociación Colombiana de Fisioterapia (ASCOFI)/Colombian Association of Physiotherapy reached a milestone: hosting the congress of the International Organisation of Physiotherapy in Mental Health (IOPTMH), a World Physiotherapy specialty group.

The ASCOFI mental health physiotherapy group was established in March 2017 and accepted as a member of the IOPTMH in April 2018. Since then, the group has promoted and supported a range of activities around physiotherapy in mental health at a national, regional, and global level. This resulted in Colombia being nominated as the location for the 10th IOPTMH conference in 2024. This was the first time in 20 years the IOPTMH conference took place outside Europe.


An evaluation survey was completed by 75% of IOPTMH conference delegates, who gave an overall high satisfaction evaluation, 8.7 out of 10.

In addition, networking activities and communication channels have been developed to continue education activities on physiotherapy and mental health and advance research and postgraduate education projects.
