President's message

As I reflect on 2025, I am struck by how much our world, and our profession, continues to change and evolve. Across all 129 member organisations (MOs) and in every region, physiotherapists are bravely navigating a healthcare landscape that is more demanding and more technologically sophisticated than at any point in our history. This annual review is an opportunity to take stock of where we have been, where we are, and what we are called to do next.

In this past year, Artificial Intelligence (AI) moved from the margins of clinical conversation to the centre of important debates in education, practice, research and policy. Across our MOs, physiotherapists are encountering AI-assisted diagnostic tools, algorithmic big data patient stratification, proliferation of home-based and wearable technologies, and AI-powered platforms. AI's influence is no longer a future scenario; it is now a reality.


The question before us is not whether AI will transform physiotherapy, but how to ensure that physiotherapists lead that transformation with the values, ethics, evidence, and an equity focus. To that end, I am pleased to announce that World Physiotherapy will convene a dedicated AI Summit in late 2026 bringing together clinicians, researchers, educators, policymakers, and technology developers

to chart a collective course for the responsible integration of artificial intelligence into physiotherapy globally.

Yet even as we look to the future, we cannot look away from the present suffering of colleagues around the world. In Ukraine, physiotherapists continue to work under conditions of active conflict, providing essential rehabilitation care to the wounded while themselves displaced, exhausted, and living under threat. Across the Middle East, our colleagues on all sides of a devastating conflict are bearing witness to and caring for levels of human injury and trauma that would test any healthcare system.

In Sudan, the Democratic Republic of Congo, Myanmar, and too many other places, physiotherapists are doing extraordinary work in extraordinarily difficult circumstances. My message to our colleagues: We see you, and we stand with you. We remain committed to ensuring that the global physiotherapy community does not turn away from those working where the need is greatest.

Beyond these crises, our profession continued to advance on multiple fronts. We strengthened advocacy for physiotherapy as an essential health service in national and global policy frameworks and



deepened partnerships across regions to address the persistent global rehabilitation workforce gap, a challenge that no technology alone will resolve.

Looking ahead to 2026, we prepare to mark a remarkable milestone: our 75th anniversary as a global organisation. The eleven founding member associations who gathered in Copenhagen in 1951 could not have imagined the world their successors would inherit. But the conviction they carried, that physiotherapy is a distinct, vital, and deeply human discipline, remains as urgent today as it was then. As we approach this anniversary, we do so not simply to celebrate, but to recommit to equity, to evidence, and to the communities we serve.

Before I close, I want to extend our warmest welcome to Sidy Dieye, who joins World Physiotherapy as our new chief executive officer. Sidy is not a stranger to our organisation. As a longstanding member of the World Physiotherapy staff, he has been a quiet but consequential force in developing many of the impactful programmes and partnerships that define our work today. He steps into this role not as an outsider learning our mission, but as someone who has lived it. His vision, energy, and deep commitment to global health equity make him exactly the right leader for this moment.

On behalf of the executive board and our entire global community, welcome, Sidy.

The year ahead will bring complexity, change, and opportunity in equal measure. I am confident we will meet each with the resolve our profession has always shown.

CEO's message

In 2025, World Physiotherapy continued to strengthen its role as the global voice of the profession: supporting our member organisations, advancing standards, influencing policy, and promoting access to quality physiotherapy services worldwide. As a mature and financially sustainable organisation representing 129 member organisations and more than 600,000 physiotherapists as of 1 January 2026, we remain committed to evolving in ways that are responsive, inclusive, and future-focused.

Our member-led model remains at the heart of our work. During 2025, physiotherapists from member organisations across multiple countries and territories contributed to our committees, expert groups, accreditation processes, and strategic initiatives. Their voluntary engagement reflects the strength of our global community and ensures that our policies and programmes are shaped by diverse perspectives and real-world experience. We also welcomed three new member organisations Botswana, Iran, and Iraq while three associations ceased membership. Despite these changes, engagement across our network remains strong and constructive.

We continued to provide operational and strategic support to our regions, including full secretariat

services for the Africa and South America regional conferences scheduled for 2026, continued support in the Asia Western Pacific and North America Caribbean regions, as well as delivering 12 regional webinars attended by nearly 1,700 participants. These activities enhance knowledge exchange, strengthen governance, and reinforce regional collaboration. A regional summit of chairs and vice chairs is planned for early 2026 to further align priorities and foster collective leadership.

Our leadership programme entered its fourth cycle, bringing together leaders from across our global membership to build skills in governance, emotional intelligence, and strategic decision-making. Participants rated the programme highly and highlighted its relevance to organisations of all sizes, reinforcing our commitment to strengthening leadership capacity at national and regional levels.

The annual membership census continues to provide one of the most comprehensive global profiles of the physiotherapy profession. With a 96% response rate in 2025, the data offers powerful advocacy tools and valuable insights. Encouragingly, 65% of member organisations reported membership growth, and progress continues toward direct access, which is now available in 39% of countries/territories represented.

At the same time, gender equity in leadership remains an area requiring sustained attention.

Our global advocacy work advanced significantly. Through collaboration with member organisations and governments in countries including Argentina, Chile, Liberia, Sierra Leone, Ecuador, Panama, Peru, Philippines, Romania, Spain, Tanzania, Tajikistan, Japan, Kyrgyzstan, Hong Kong, and Türkiye, we supported workforce development, regulatory reform, direct access legislation, and the strengthening of entry-level education programmes. These initiatives align closely with the World Health Organization (WHO) Rehabilitation 2030 agenda and reinforce our commitment to building rehabilitation capacity worldwide.

At the global level, we amplified the voice of physiotherapy through active engagement in the World Health Professions Alliance, participation in the 78th World Health Assembly, and contributions to the World Rehabilitation Alliance. Our new memorandum of understanding with Humanity & Inclusion further strengthens our role in humanitarian and development contexts.

World Physiotherapy Congress 2025 in Tokyo brought together nearly 5,000 participants,

showcasing cutting-edge research and global perspectives.

Through bursaries, open-access archives, and specialty group engagement, we ensured broad access and lasting impact. Preparations for Congress 2027 in Guadalajara are well underway.

Looking to the future, our priorities remain steadfast: further strengthening education and enhancing our accreditation service, broadening access to high-quality CPD, identifying and championing global research priorities, and advancing advocacy for rehabilitation within health systems. We are equally committed to adding value to membership and delivering tailored support to our member organisations, ensuring their needs are met across all regions and contexts. Underpinned by sustainability and collaboration, World Physiotherapy confidently continues to evolve, harnessing our shared strengths to advance the profession and improve health outcomes worldwide.

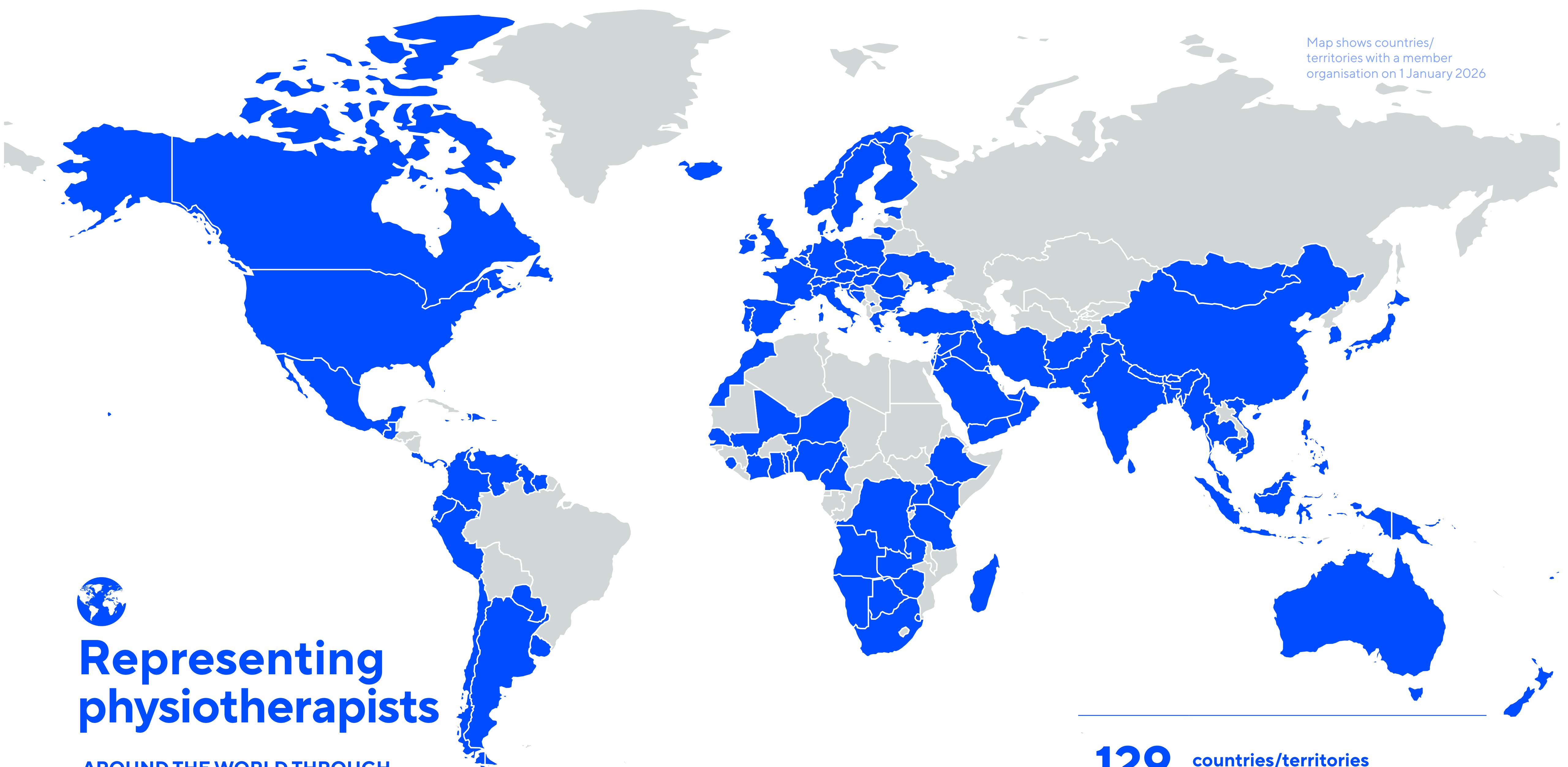

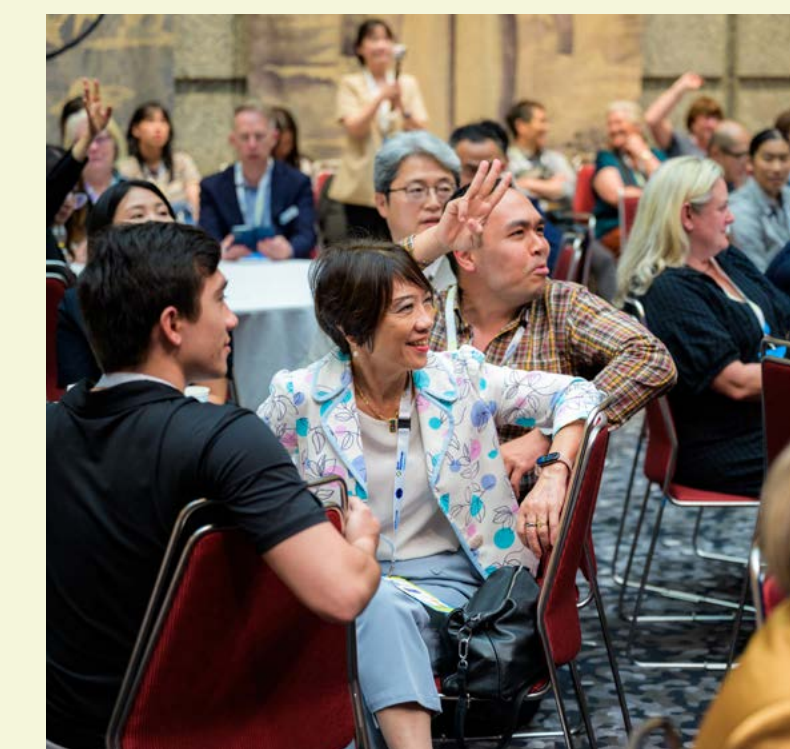
Regional summit

A two-day summit is planned for early 2026 of World Physiotherapy regional chairs and vice chairs from its Africa, Asia Western Pacific, Europe, North America Caribbean, and South America regions. It will be held in Istanbul, Türkiye and will be an opportunity for regions to exchange experiences and ideas, share information, identify common challenges, and foster collaboration and growth.

SPECIALTY GROUPS

Staff facilitated five online and one in-person specialty group informal meetings during 2025. The meetings provided presidents and chairs of specialty groups the opportunity to share experiences, challenges, and best practice to improve the governance and operations of their specialty groups.

During the World Physiotherapy Congress 2025, specialty groups were given complimentary booths in the global village, allowing them to showcase their work to the global community and forge new connections with physiotherapists from around the world. All 14 specialty groups also held networking sessions at congress, enabling round table discussions to take place in small groups.





Humanitarian support

During 2025 World Physiotherapy continued to offer support to member organisations facing conflict situations and environmental disaster, including taking a lead role in providing clinical webinars to physiotherapists in Myanmar through collaboration with the:

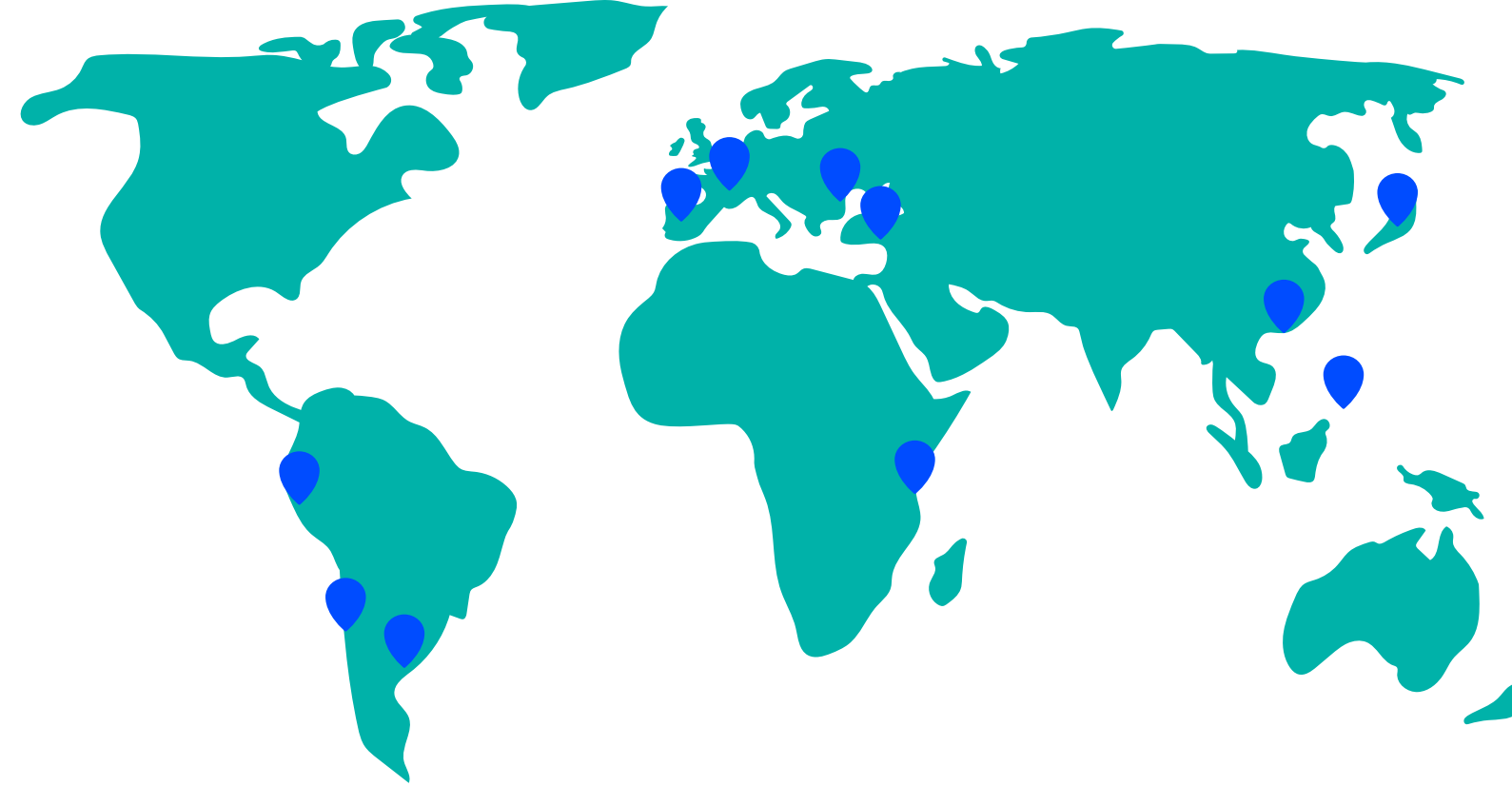

Advocacy

During 2025 World Physiotherapy supported member organisations with advocacy activities in the following countries: Argentina, Chile, France, Hong Kong, Japan, Peru, Philippines, Romania, Spain, Tanzania, and Türkiye.



JAPAN PHYSICAL THERAPY ASSOCIATION (JPTA)

World Physiotherapy and the Japanese Physical Therapy Association (JPTA) have jointly urged the adoption of international standards in physiotherapy education in Japan.

JPTA president, alongside World Physiotherapy president and CEO, held high-level meetings in Tokyo with Japan's Minister of Health, Labour and Welfare, and the State Minister of Education, Culture, Sports, Science and Technology. Together, they advocated for reforms to align physiotherapy curricula with global benchmarks. This call to action follows Iryo Sosei University becoming the first Japanese institution accredited under the World Physiotherapy accreditation service. The initiative reflects a broader commitment to strengthening Japan's physiotherapy workforce in response to the growing healthcare needs of an ageing population.



HONG KONG PHYSIOTHERAPY ASSOCIATION (HKPA)

Following advocacy efforts by World Physiotherapy, in July physiotherapists in Hong Kong celebrated a landmark win after the Legislative Council passed the 2025 Supplementary Medical Professions (Amendment) Bill, enabling people to access physiotherapy services without a prior referral in certain circumstances. Physiotherapists can now provide care to people directly in specified conditions, without the need for an intermediary consultation. Previously, people were required to get a referral from a doctor before receiving physiotherapy, creating delays and added burden on the public healthcare system.



TURKISH PHYSIOTHERAPY ASSOCIATION

Following advocacy efforts by World Physiotherapy and the Turkish Physiotherapy Association/Türkiye Fizyoterapistler Derneği, physiotherapists in Türkiye now have the authority to establish private clinics under the supervision of the ministry of health. The landmark regulation was enacted on 29 March 2025 and is the first official regulation of its kind in Türkiye.



Leadership programme



LEADERSHIP PROGRAMME

The leadership programme continued to empower physiotherapist leaders worldwide.

The 2024/2025 online programme cycle brought together leaders of World Physiotherapy member organisations in 23 countries/territories to strengthen leadership capacity across the global physiotherapy community. The participants completed the programme by sharing case studies relevant to their leadership context.

The evaluation of the 2024/2025 programme indicated that participants highly appreciated the programme, rating their overall experience as being 89 out of 100.

With a new cohort starting in September 2025, the 12-month programme features nine modules with online learning materials provided by subject matter experts complemented by monthly live discussions.

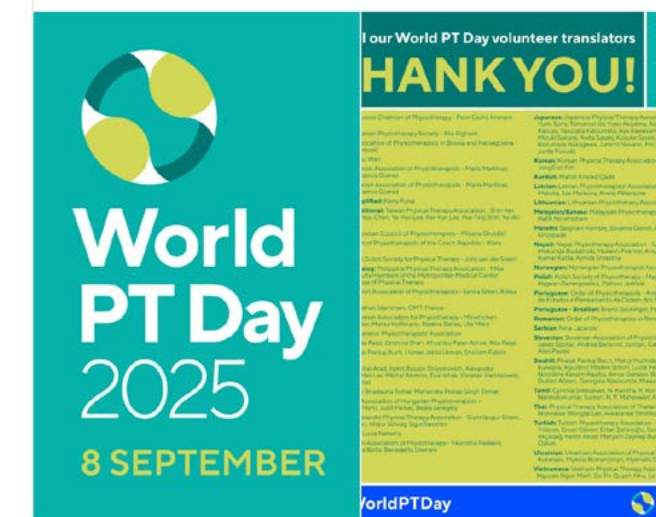

Influence and reach

World Physiotherapy works collaboratively with our member organisations, regions, specialty groups, and other stakeholders to advance the profession, increase access to physiotherapy services, and improve outcomes for consumers.



Projects and programmes



ECUADOR AND PANAMA

In November 2025 World Physiotherapy completed visits to Ecuador and Panama to advance efforts to strengthen the physiotherapy profession and expand access to local rehabilitation services. World Physiotherapy representatives collaborated with the:

- Ecuadorian Society of Physiotherapy/ Sociedad Ecuatoriana de Fisioterapia
- Panamanian Association of Physiotherapy and/or Kinesiology/ Asociacion Panamena de Fisioterapia y/o Kinesiologia (APAFIK)



“For the Ecuadorian Society of Physiotherapy (SEF), the World Physiotherapy visit goes beyond protocol; it represents a vital strategic intervention given the current state of the profession in the country. This support addresses job insecurity, academic fragmentation, and professional encroachment, promoting the legislative reforms and technical planning urgently required in Ecuador.”

TAJIKISTAN

In July World Physiotherapy conducted a series of clinical education training sessions in Dushanbe, Tajikistan. The sessions were aimed at strengthening clinical skills and educational capacity within local rehabilitation institutions. The initiative is part of World Physiotherapy’s ongoing partnership with the Republican Medical College under the Ministry of Health, which began in 2019, and has resulted in the successful development and implementation of the region’s first entry-level physiotherapist education programme. Further clinical education training sessions are scheduled to continue in 2026, supporting the growth of rehabilitation services across both urban and rural communities.



LIBERIA

A workshop was co-led with the director for the government’s non-communicable diseases and injury division. There is currently only one trained physiotherapist in Liberia, the key priority for this initiative was to establish the first entry-level physiotherapist programme to address urgent workforce needs.



KYRGYZSTAN

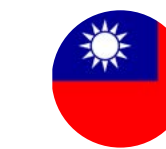
World Physiotherapy representatives attended a stakeholder meeting to explore opportunities to develop consensus around university programmes for physiotherapist education. The meeting included representatives from international and local organisations and institutions, and ministries of health, education, and social welfare. The meeting represented a critical step toward strengthening rehabilitation education and clinical capacity in Kyrgyzstan.

In alignment with the WHO Rehabilitation 2030 framework, it highlights the importance of building a well-trained, competent workforce to meet growing rehabilitation needs. Primary outcomes included the development of a roadmap for the implementation of the university programmes and establishing a working group to liaise with government and institutions on defining the standards and scope of practice for physiotherapy professionals.



SIERRA LEONE PHYSIOTHERAPY ASSOCIATION (SLPA)

World Physiotherapy met with representatives of government health and education ministries with the focus on strengthening the existing entry-level physiotherapy education programme, and exploring the creation of a master's programme to build advanced skills and leadership, alongside the development of SLPA. In addition, a workshop was held, which was co-led by the deputy director for the government's non-communicable diseases and mental health, and SLPA president. The visit was in collaboration with World Hope International. These initiatives directly support the WHO Rehabilitation 2030 agenda, which calls for stronger rehabilitation services, integration into health systems, and investment in the health workforce worldwide.



TAIWAN

Two physiotherapy students from the Taiwan Physical Therapy Association/ 社團法人臺灣物理治療學會 collaborated with World Physiotherapy to support our strategic work in two key areas: direct access, using data from World Physiotherapy's annual membership census, and the emerging role of artificial intelligence (AI) in physiotherapy. The collaboration underscores the power of global partnerships in advancing the profession. By tackling both policy reform in direct access and technological innovation via AI, the projects reflect a forward-looking agenda, one that embraces evidence-based advocacy, responsible innovation, and deeper international engagement in the field of physiotherapy.





Global leadership and influence

Our contribution to thought leadership and global influence has been widely recognised in a number of different ways during 2025.

WHO 78th World Health Assembly (WHA78):

World Physiotherapy and representatives from the profession attended activities during WHA78. This included a World Health Professions Alliance (WHPA) side event and, as part of WHPA, the presentation of constituency statements to reaffirm a critical message: investing in health professionals is not a cost, but a cornerstone of resilient, high-quality healthcare systems and the path to universal health coverage.

As part of WHPA, World Physiotherapy also contributed to constituency statements presented at WHA78 on:

- universal health coverage
- health emergencies
- climate change

WHPA brings together the global organisations representing the world's dentists, nurses, pharmacists, physiotherapists and physicians and speaks for 47 million health care professionals in 179 countries and territories. WHPA works to improve global health and the quality of patient care and facilitates collaboration among the health professions and major stakeholders. World Physiotherapy has been a member of WHPA since 2010.

OTHER WHPA ACTIVITIES INCLUDED:

- An interprofessional webinar: Bridging global health agendas: NCDs (non-communicable diseases), AMR (antimicrobial resistance), and interprofessional collaboration.
- Press release issued calling on global leaders and countries to invest in health workforce to win global fight against non-communicable diseases.
- On World Humanitarian Day, WHPA together with humanitarian organisations, called on world leaders to act for humanity and protect health professionals working in conflict zones. It highlighted that life-saving health services, which are already underfunded and overstretched, are facing unprecedented pressure as conflicts intensify, targeted attacks on health facilities are multiplying, and funding is cut.

- An open letter to WHO from the WHPA leadership demanding that WHO continue to provide support and investment in the health workforce despite recent funding cuts and organisational restructuring.
- WHPA called for the safety of health professionals and patients at the WHO's 7th Global Ministerial Summit on Patient Safety.
- Ahead of its attendance at the invitation-only WHO Second Global Conference on Air Pollution and Health, WHPA signed a Call to Action demanding a future with clean air for all.
- WHPA delivered statements on the health workforce and on climate change at the WHO's Executive Board (EB) in February, speaking up for health professionals. WHPA called for Dr. Tedros. WHO Director-General, to fulfil his commitment to reducing unethical recruitment of health professionals, largely driven by high-income countries and agencies depleting the health workforce in low-income countries often facing severe shortages themselves. On climate change, WHPA called for health professionals and civil society to be included in the development of climate-health strategies.

Humanity & Inclusion

In May World Physiotherapy signed a memorandum of understanding (MOU) with Humanity & Inclusion (HI).

Through the MOU, World Physiotherapy will continue active engagement with HI, recognising the role that each organisation plays in advancing rehabilitation and improving the health and wellbeing for all.

HI is a charity working in 60 countries around the world running hundreds of projects in emergency, chronic crisis, reconstruction and development settings. Physiotherapy and rehabilitation form a significant part of its work.



World Rehabilitation Alliance

Founded in 2023, the World Rehabilitation Alliance (WRA) is a WHO global network of stakeholders whose mission is to support the implementation of the Rehabilitation 2030 Initiative through advocacy activities.

It focuses on promoting rehabilitation as an essential health service that is integral to Universal Health Coverage and to the realisation of Sustainable Development Goal 3: Ensure healthy lives and promote well-being for all at all ages.

World Physiotherapy is contributing to WRA workstreams on:

- emergencies
- primary care
- research
- the advocacy and communications task force





Promoting physiotherapy

Michel Landry, World Physiotherapy president, gave keynote presentations or spoke at a number of events in 2025, including:

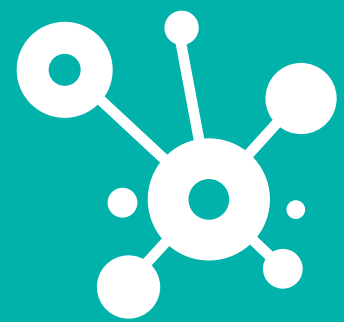
- Irish Society of Chartered Physiotherapists conference in Gormanston, Ireland, in April.
- Attended the Taiwan Physical Therapy Association's (TPTA) 50th Anniversary Congress, themed "A Legacy of Growth, A Future of Possibilities- Extend beyond 50 Years". This two-day event consisted of two special forums, scientific conference, annual membership meeting and continuing education courses. More than 300 physiotherapists from 14 countries participated in the congress, with Michel Landry, and Suh-Fang Jeng, World Physiotherapy vice president, featuring as special guests at the Legacy Forum.

- A high-level meeting with the Minister of Health, Labour and Welfare and Vice Minister of Education, Culture, Sports, Science and Technology in Japan, took place in May after the World Physiotherapy Congress.
- Video message for Japanese Physical Therapy Association general meeting in June.

Members of the World Physiotherapy board, and staff also gave presentations at several events in 2025, including:

- AC Forum annual meeting in January on reasons for identifying research gaps in your profession.
- JPTA education symposium (as part of congress legacy project) in January on World Physiotherapy educational standards and the efforts in Germany to establish bachelor's degrees as the entry-level qualification for physiotherapists.
- Chile specialty group conference DENAKE in August on specialty groups, global physiotherapy, and leadership.
- An executive board member of World Physiotherapy attended a national conference in Uruguay in August, advocating for the creation of an updated regulation, supporting the member organisation to establish standards, develop education, and regulate the profession.

- Argentine Association of Kinesiology national conference in October on direct access.
- Polish Society of Physiotherapy in November.
- Second International Conference on Active Pain Management in Spain in October on how to foster changes in healthcare systems.
- Germany: Forschungssymposium Physiotherapie in November on World Physiotherapy research priorities project plans.
- Cambodia Physical Therapy Association annual congress in November on World Physiotherapy's role in supporting global physiotherapy development.
- ADAPT Physiotherapists for Global Health conference in November on strengthening global physiotherapy development across diverse contexts - facilitating local ownership, evidence-based practice, knowledge sharing and sustainable context-specific practices.

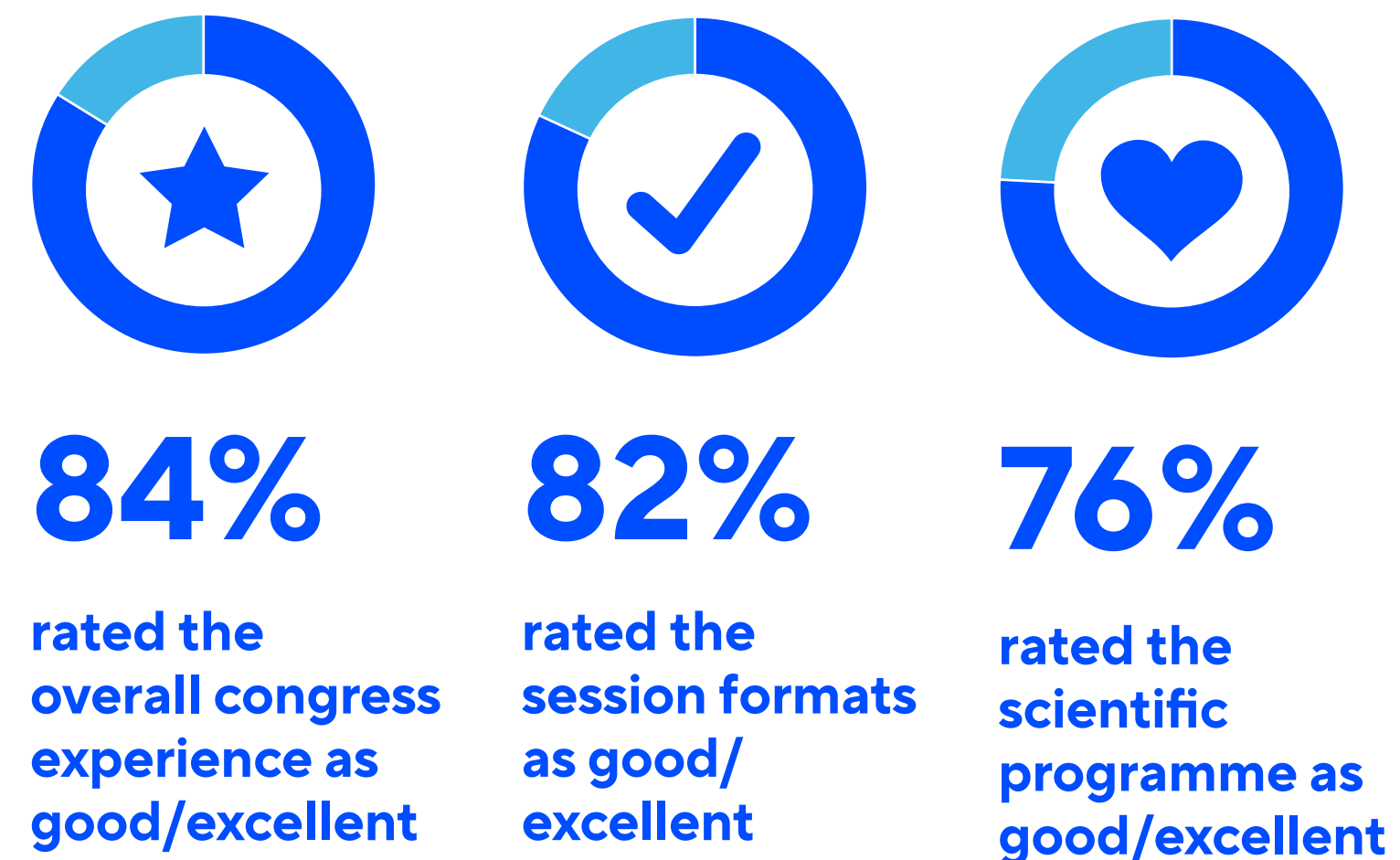
PARTICIPANTS BY REGION

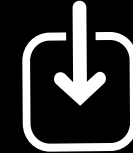
Congress bursary programme

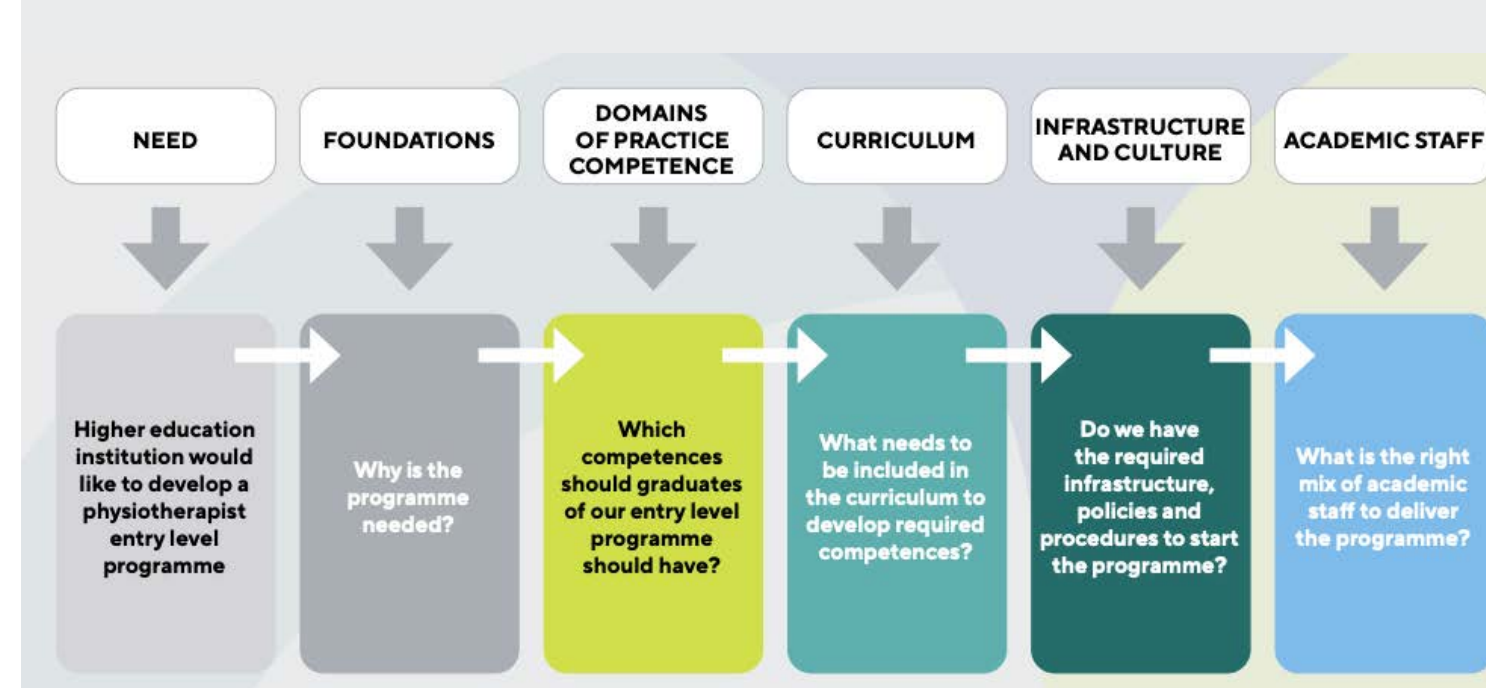




CPD event recognition service

World Physiotherapy continued to provide CPD event recognition through its service for providers of continuing professional development (CPD). The service uses a peer review process to ensure submitted events meet World Physiotherapy CPD quality requirements. Each event is awarded World Physiotherapy continuing education units (CEUs), on the basis of one CEU for one hour of learning.

The CPD event recognition service is helping advance the profession by offering CPD providers a mechanism for quality assurance. The service is also increasing access to quality CPD opportunities for physiotherapists and physiotherapist assistants throughout their careers.

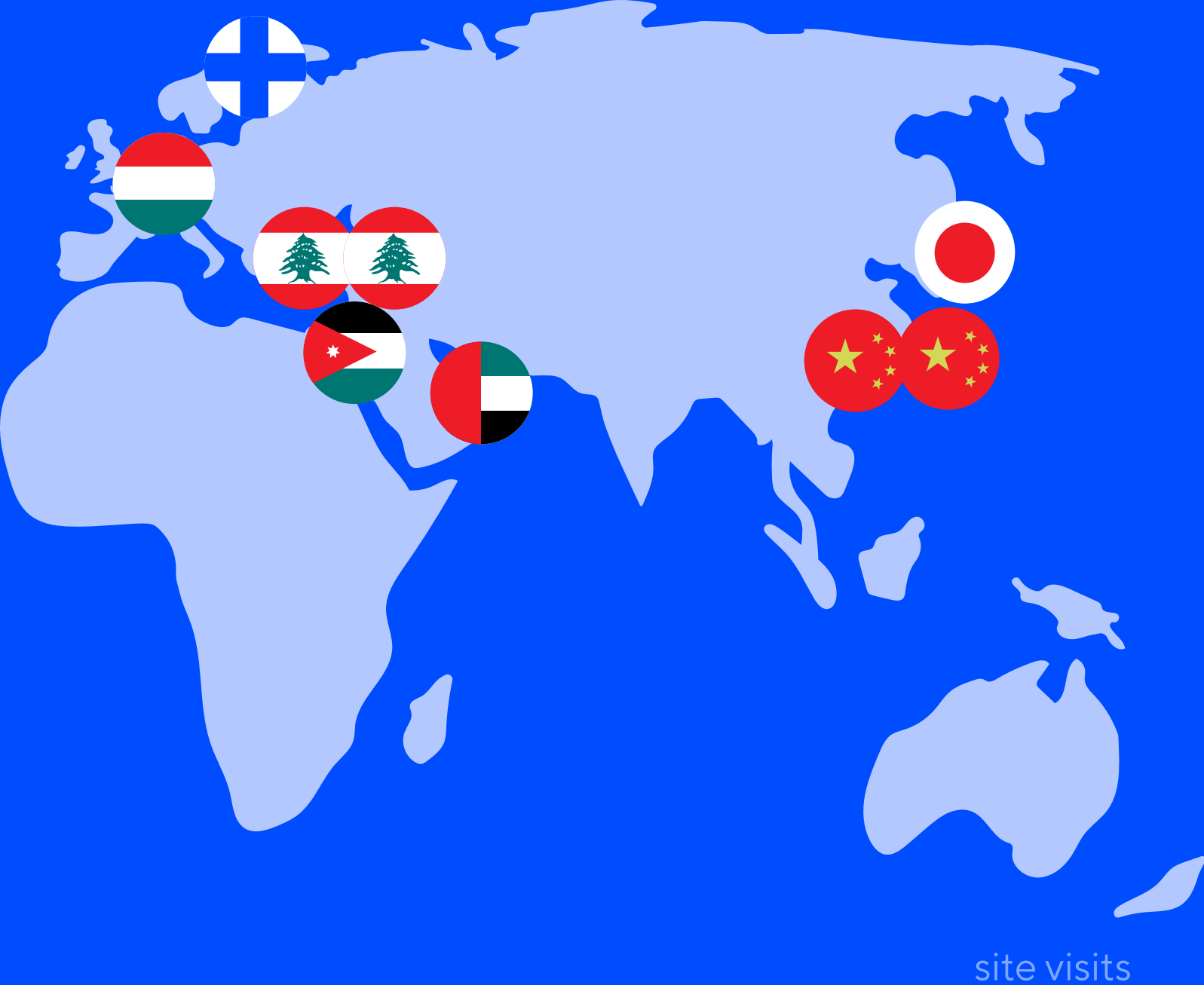


Education

The education committee advises staff on relevant World Physiotherapy services, projects, and activities. Education committee members delivered two webinars on physiotherapist life-long learning to discuss quality assurance processes and global perspectives on the quality of physiotherapist education and CPD to improve practice.

THE EDUCATION COMMITTEE CONTINUES TO PROVIDE:

- 1 strategic advice and recommendations to the board on education matters that further the purpose and strategy of World Physiotherapy
- 2 advice and recommendations to the staff and board on policy, project areas, and activities that advance the development in education in the profession
- 3 strategic oversight of the accreditation committee and recommendations relating to the future of accreditation services.



Accreditation

The accreditation service undertook nine site visits in 2025: two in China, two in Lebanon, one in Finland, one in Hungary, one in Japan, one in Jordan, and one in the United Arab Emirates.

A model for remote site visits was developed and implemented in 2025 for use in countries/territories affected by conflict and/or public health emergencies to assure continuity of the accreditation service.

ENTRY-LEVEL EDUCATION PROGRAMMES

In 2025, the accreditation committee agreed to grant accreditation status to nine physiotherapy entry-level education programmes.

Three programmes were accredited for the first time;

- Qatar University (Qatar)
- Shanghai University of Medicine and Health Sciences (China)
- Iryo Sosei University (Japan)

Six were reaccredited;

- Tongji University
- Fujian University of Traditional Chinese Medicine
- Kunming Medical University
- Capital Medical University (all four in China)
- Satakunta University of Applied Science (Finland)
- Semmelweis University (Hungary)

This brings the total number of programmes accredited by World Physiotherapy to 23.

Research priorities study

World Physiotherapy is undertaking a global initiative to identify research priorities that reflect the collective needs of the profession.

It is designed to provide insights into research priorities on professional issues, beyond clinical practice, for the global physiotherapy profession.

This will help World Physiotherapy better understand research priorities, and enable further assistance with prioritising future research and disseminating research activities.

By inviting input from physiotherapists, researchers, journal editors and organisations from all regions and income settings, World Physiotherapy is building a foundation for more strategic, globally aligned research investment - ensuring the future of the profession is shaped by shared priorities and inclusive participation.

At a session at World Physiotherapy Congress 2025, Mark Elkins from the Australian Physiotherapy Association emphasised that priority identification is only the beginning. Plans are in place to monitor uptake through downloads, citations, and member feedback. The project will conclude and the list of priorities will become available in 2026.

Following consultation with our member organisations on their priorities for World PT Day, the next four years (2026-29) will focus on non-communicable diseases. 2026 will highlight cardiovascular disease and stroke, and the role of physiotherapy in their prevention and rehabilitation.



Governance



Structure, governance, and management

In 2020, WCPT changed its operating name to World Physiotherapy. This change was part of a rebrand and has been implemented across all externally facing platforms and materials. WCPT continues to be used for all governance and financial matters.

World Physiotherapy is an unincorporated international professional association founded in 1951. The organisation's objectives, membership and governance structures are contained in the constitution, which was approved at the 19th general meeting of member organisations, held in Geneva, 8-9 May 2019, which replaced the Articles of Association.

At the general meeting in 2023, the member organisations approved the process to transition from an unincorporated organisation to a charitable incorporated organisation.

To that end, a new charitable incorporated organisation (CIO) in the name of World Physiotherapy was registered on 13 March 2024 with the Charity Commission for England & Wales (charity number 1207425). Permission has been given by the Charity Commission to transfer the business of the unincorporated charity to the CIO. Once the members of WCPT approve the final constitution of the CIO, and give permission for the trustees to effect a transfer, the process can be completed. Note that all instances of "World Physiotherapy" in this document refer to WCPT (the charity) and not the CIO. The CIO is not currently trading and only holds a small amount of cash in the bank account.

The trustees confirm that, during 2025, World Physiotherapy has complied with the provisions of the constitution and current statutory requirements applicable to charities. The trustees also confirm they have had regard to guidance issued by the Charity Commission as to the public benefit requirement.

World Physiotherapy has a subsidiary limited company, which exists to collect costs and income for congress events held every two years. It was incorporated on 7 December 2012 and is registered at Companies House for England & Wales, company registration number 08322671.



The business of World Physiotherapy is conducted through the general meeting of member organisations, executive board, regions, and specialty groups (previously referred to as subgroups). The World Physiotherapy executive board (“the board”) is the charity’s board of trustees.

World Physiotherapy’s general meeting of member organisations is held every four years. The meeting approves changes to the constitution, elects the president and vice president, names the members of the board, admits member organisations, approves subscription rates, approves professional policy statements, and considers motions submitted by member organisations. The next General Meeting is due to be held in May 2027.

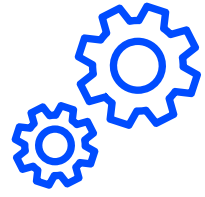
The board usually meets in-person at least annually and by teleconference as necessary to define the strategic plan and areas of activity for World Physiotherapy. It considers grant making, investment, reserves, and risk management, and approves the annual budget, policies, and monitors performance. During 2025 the board held eight teleconferences and three in-person meetings.

The charity’s plans for the future include, planning for a general meeting and congress in 2027, developing projects in Africa, central America, and central Asia, and continuing to support member organisations and their members across a range of activities and events. It is also intended that the business of the charity is transferred to the CIO (Charitable Incorporated Organisation), subject to member approvals.

World Physiotherapy does not meet any of the criteria for fundraising disclosure under the Charities (Protection and Social Investment) Act 2016. Therefore, no disclosure will be made.

World Physiotherapy’s executive board is elected by World Physiotherapy member organisations and consists of the president, vice president, and a member from each region. The president and vice president are elected at the World Physiotherapy general meeting held every four years. Regional executive board members are elected by their region. All new board members are invited to participate in an induction process on commencement. Current board members and staff are encouraged to participate so there is a shared understanding of roles and responsibilities. The following committees are responsible for specific areas of World Physiotherapy’s activities: accreditation, appeals, awards, congress programme committee, education, finance, membership.





Administration and management

The day-to-day administration and management of World Physiotherapy is delegated to the chief executive officer.

External relations

World Physiotherapy is in official relations with the World Health Organization (WHO) and has consultative status with the United Nations Economic and Social Council (ECOSOC) and United Nations Children's Fund (UNICEF).

Since 2010 World Physiotherapy has been a member of the World Health Professions Alliance (WHPA), comprising the International Council of Nurses (ICN), the International Pharmaceutical Federation (FIP), the World Dental Federation (FDI), and the World Medical Association (WMA).

World Physiotherapy has Memorandums of Understanding with World Health Organization (WHO), Humanity & Inclusion (H&I) and the International Committee of the Red Cross (ICRC).

World Physiotherapy is a founding member of the World Rehabilitation Alliance which commenced in June 2023, with the aim of being a powerful advocacy platform to further the development of rehabilitation around the world.



Membership

World Physiotherapy member organisations are national professional associations representing physiotherapists.

During 2025, applications for membership were received from three national physiotherapy professional associations. An electronic vote took place, and three associations were formally admitted as member organisations from 1 January 2026 – bringing the total number of member organisations to 129, representing more than 600,000 physiotherapists worldwide.

Each member organisation has the right to be represented at the general meeting.

Regions are five geographic groupings of member organisations: Africa, Asia Western Pacific, Europe, North America Caribbean, and South America. Regions exist to assist the development of the profession in the geographic area. Regions have the right to send a delegate to the general meeting, but these delegates do not have a right to vote.

Specialty groups are international physiotherapy organisations, which represent a specific area of professional interest and meet World Physiotherapy criteria for specialty group recognition. They are independent entities. They promote the advancement of physiotherapy in their field and are organised to exchange scientific knowledge.

Upon application, they are approved as a specialty group by the board and confirmed by the general meeting. They are reconfirmed at each successive general meeting.

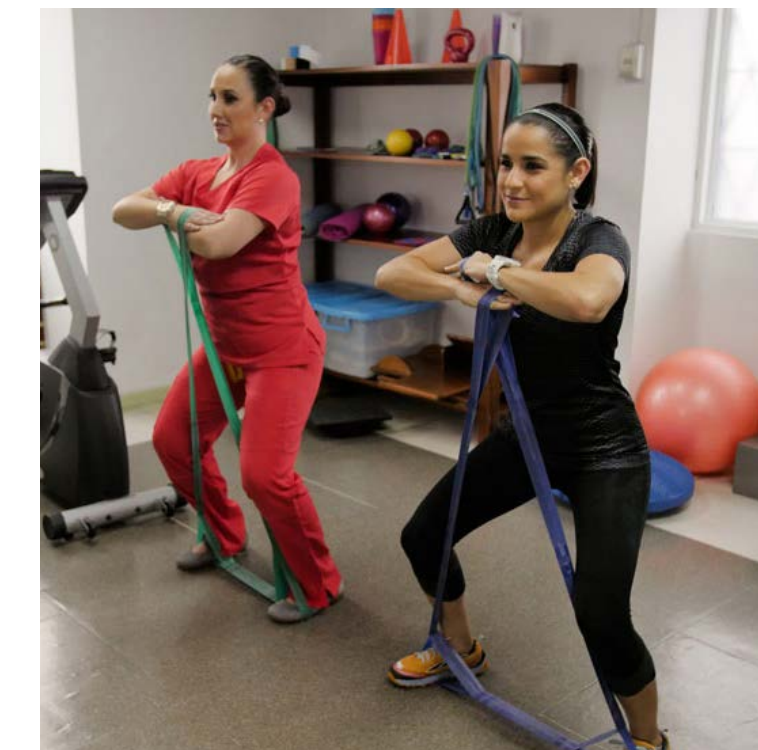
There are currently 14 specialty groups recognised by World Physiotherapy.

Specialty groups have the right to send a delegate to the World Physiotherapy general meeting, but these delegates do not have a right to vote.

World Physiotherapy has two networks:

- physiotherapist educators
- students and early career professionals.

These networks support the exchange of ideas, experience and expertise among individual physiotherapists across social media platforms.





Risks

The trustees have reviewed the major risks to which World Physiotherapy is exposed and have established systems to mitigate those risks.

This risk management framework defines World Physiotherapy processes for managing risk including the implementation, monitoring, reviewing, and improvement of risk management. World Physiotherapy maintains separate risk registers for World Physiotherapy and WCPT Trading Ltd.

The key risks facing World Physiotherapy and the process in place to manage these risks:

- Membership: concerns regarding non-renewal of membership or non-payment of fees are addressed by the strategic plan and ongoing membership engagement activities.
- Membership: concerns regarding member organisations not complying with membership requirements are addressed by the 2019 constitution.
- Governance: concerns regarding executive board members acting outside of their delegation are dealt with by the executive board governance framework. The governance framework documents the required practices and procedures related to the board and committees, these include:
 - board charter which identifies the responsibilities, accountabilities, and relationships between World Physiotherapy's governance bodies
 - board operating guidelines which guide the scheduling, agenda and timing of meetings and requirements for the presentation, lodgement, and approval process for providing information for board and committee consideration.

The key risks facing WCPT Trading Ltd and the process in place to manage these risks:

- Congress income: there is a risk that participant numbers and/or exhibition/ sponsor income falls short of budget, posing risk of financial loss to World Physiotherapy. This risk is managed by conservative budgetary management grounded in available data as well as industry insights.
- Currency fluctuations: there is a risk that major changes in exchange rates after charges/ budget is set will result in a financial loss to World Physiotherapy. This risk is managed through the appointment of a foreign currency adviser and regular conversion of foreign currency balances to sterling.



Objectives and activities for the public benefit

As the international voice of physiotherapy, World Physiotherapy's vision is for everyone to have universal access to quality physiotherapy services where and when needed.

World Physiotherapy's purpose is to represent physiotherapy across the globe, advancing the profession, and advocating access for all, to improve health and wellbeing.

World Physiotherapy provides a public benefit by providing a range of support and services for member organisations and their members to further the global physiotherapy profession and improve global health through advocacy, education, projects, and events.

The board determines the priorities within the strategic plan, within the resource constraints of

World Physiotherapy, and continually reviews these priorities considering changing circumstances. The trustees, having due regard to guidance issued by the Charity Commission, confirm that World Physiotherapy complies with the public benefit requirement in section 4 of the Charities Act 2011.

REMUNERATION POLICY FOR KEY MANAGEMENT PERSONNEL

World Physiotherapy is committed to ensuring a proper balance between:

- paying our staff and others who work for us fairly so that we attract and retain the best people for the job; and
- careful management of our charity funds. In so doing we will ensure the greatest effectiveness in delivering our charitable objectives and fulfilling our purpose. When determining the salary for a newly created post, we will collect information about comparable roles in similar organisations. We will use this information to benchmark our own salaries, normally aiming to set it at a level that appears to represent the market average.

SALARY BANDING

Salaries for all current posts, other than the chief executive officer, will fall within a salary band, based on the skills required for the role, the responsibility of the role, and the experience of the person.

Each year the trustees will consider awarding a cost of living adjustment for all staff when setting the following year's annual budget.

This increase is to reflect changes in the cost of living and is entirely at the discretion of the trustees.

The trustees' considerations will take into account economic forecasts for the rate of inflation, as well as the general employment market. They will then determine whether this is appropriate in the context of the charity's financial situation and the charity's performance.

FUTURE PLANS

Plans for the future include holding our congress as well as general meeting in Guadalajara, Mexico in May 2027.

We will continue with our development work in Africa and central Asia, explore new opportunities in South America, and continue to support our member organisations and their members with a range of activities and events.

It is also intended that the business of the charity is transferred to the CIO (Charitable Incorporated Organisation), subject to member approvals.



Financial review

2025 was a successful year in a variety of ways.

Sidy Dieye was appointed as CEO, and continues to develop and grow the work of World Physiotherapy. The congress in Tokyo was a particular success, with more than 4,500 in attendance, 35% of whom were first time participants. There was a surplus for the year of over £452k, resulting in a healthy level of reserves to underpin future activity.

Income for the year was lower than budget, as the attendance numbers at congress fell short of the original ambition. However, through a combination of unbudgeted grant income and cost savings, the results for the year reduced the overall variance.

The statement of financial activities for 2025 shows a net surplus of £452,560 and the balance sheet shows total net assets of £1,316,714 as at 31 December 2025. The table 'Financial year 2025' separates the Charity and Trading entities income and expenditure to show their individual performance.

World Physiotherapy's charitable activities are funded through annual membership subscriptions, charitable grants, donations as well as the transfer of the taxable profits of the trading subsidiary.

The membership subscription rate is set at the general meeting of member organisations. The rate for 2025 was an increase of 2% on the previous year, namely £1.65 per member of each member organisation in high-income countries/territories; £1.24 per member in middle-income countries/territories; and £0.83 per member in low-income countries/territories.

WCPT Trading Ltd manages the congress operations, which typically take place every second year. In 2025 the congress took place in Tokyo, Japan.

Group income was £3,624k for 2025, of which member organisation subscription fees were £984k.

Investments showed an overall loss of £2.8k in the year, compared to an unrealised gain of £28.5k in 2023. We continue to monitor the investment landscape and to make commitments to the long term allocation of funds where it is considered appropriate.

FUNDS HELD AS AN AGENT

During the year the charity acted as an agent for the Global Rehabilitation Alliance (GRA), facilitating their administration. At the end of 2022 the activities of GRA were paused, as the World Health Organization (WHO) started a new group, World Rehabilitation Alliance (WRA).

The WRA is funded by WHO and has taken over the work of the GRA.

The charity is holding the GRA funds as an agent until the future of WRA/GRA has been agreed. At the end of the year, a balance of £15,710 remained held as an agent and is included in other creditors.

INVESTMENT POLICY AND PERFORMANCE

The trustees invest World Physiotherapy's funds, which are in excess of current cash flow requirements, with the objective of preserving the real value of capital, as well as for income generation.

During 2025 net new investments were made in:

- "COIF Charities Global Equity Income Fund", a Common Investment Fund managed by CCLA (£150k)
- "Rathbones Core Investment Fund for Charities", a non-UCITS Retail Scheme that qualifies as an alternative investment fund within the meaning of AIFMD, and is managed by Rathbones Unit Trust Management Limited (£150k). On 26th September 2025 the "Rathbones Core Investment Fund for Charities" was merged into the "Rathbones Charity Growth and Income Fund". The 347,342.28 shares in the "Rathbones Core Investment Fund" were cancelled and 374,264.65 shares were issued in the "Rathbones Charity Growth and Income Fund".

The trustees continue with a policy of holding and, whenever possible, increasing investments for the long term. The market continues to be subject to volatility and the outlook remains uncertain.

Prior year adjustment

A prior year adjustment was made in the results of the charity as discussed in note 14 of the financial statements. A grant awarded to the charity in the comparative period had been recognised in the

financial statements in accordance with the annual allocation of the amounts awarded. In order to comply with SORP, the Trustees have adjusted the comparative figures to recognise grant income in full at the point where there is entitlement to income, that income can be measured reliably, and there is reasonable certainty of receipt. A prior year adjustment has been made to the figures previously reported as at 31st December 2024 to include £173,472 of additional grant income. This resulted in the reserves for both the charity and the group increasing by £173,472 to £173,900 for the year ended 31 December 2024.

Post balance sheet events

There were no notable post balance sheet events.

Other disclosures

World Physiotherapy does not meet any of the criteria for fundraising disclosure under the Charities (Protection and Social Investment) Act 2016. Therefore, no disclosures have been made.

Going concern

The trustees prepared the financial statements on the going concern basis after assessing the likelihood and scale of various key risks which could affect income and expenditure.

The trustees remain confident in the ongoing financial viability of World Physiotherapy, for at

least the next 12 months following the date of signature on the financial statements.

Reserves

The purpose of the unrestricted funds is to mitigate the risk of unforeseen expenditure or a temporary reduction in income. World Physiotherapy reviews reserves on an annual basis at the time of setting the budget. This involves a risk-based assessment of factors likely to reduce income or increase expenditure. A reserves review would also be undertaken in the event an unexpected material financial occurrence.

WCPT Trading Ltd is expected to be profitable in the long term and all distributable profits made are donated to the charity.

World Physiotherapy reviews the target level of reserves each year and was set at £400k in December 2025. The free reserves (defined as unrestricted reserves less the value of fixed assets) as at 31 December 2025 were £398.7k. In addition, there were over £732k of investments which could be quickly converted to cash for immediate use.

It is expected that the reserves will decrease during 2026 as this is typical in a non-congress year. The trustees remain content that the level of reserves remains appropriate.

Statement of trustees' responsibilities

IN RELATION TO THE FINANCIAL STATEMENTS

The trustees are responsible for preparing the trustees' annual report and the financial statements in accordance with applicable law and UK accounting standards (UK generally accepted accounting practice).

The law applicable to charities in England and Wales requires the trustees to prepare financial statements for each financial year, which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources of the charity for that period. In preparing the financial statements, the trustees are required to:

- select suitable accounting policies and apply them consistently
- observe the methods and principles in the Charities SORP
- make judgements and estimates that are reasonable and prudent
- state whether applicable accounting standards have been followed, subject to any departures disclosed and explained in the financial statements

- prepare the financial statements on the going concern basis, unless it is inappropriate to assume that the charity will continue its activities.

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act 2011, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the governing document. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

AUDITOR

The charity's auditor, James Cowper Kreston, was appointed by the executive board in May 2024.



COMPANY INFORMATION

The World Confederation for Physical Therapy is a registered charity in England and Wales, number: 234307. The WCPT's registered address is Greenham Business Park, 2 Communications Rd, Newbury RG19 6AB.

Notes to the accounts (1)

1. ACCOUNTING POLICIES

1.1 Basis of accounting

The consolidated financial statements are prepared under the historical cost convention, with the exception of investment assets, which are included at market value. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities (SORP FRS102), applicable to accounting periods commencing 1 January 2015, UK Accounting Standards and the Charities Act 2011. The accounts are denominated in £ sterling.

Going concern

The trustees have considered plans to the end of 2027, including for the congress in Guadalajara, Mexico in May 2027, making various assumptions about the change in numbers of member organisations, fees charges etc, and their effect on the level of reserves. A significant part of the reserves are held in cash and, if necessary, there are investments that can be converted to cash at short notice.

The trustees are satisfied WCPT is a going concern for at least the next 12 months and have prepared the financial statements on this basis.

1.2 Income and debtors

Income is recognised when the charity is legally entitled to it, receipt is probable and income can be measured with reasonable accuracy. Donations are credited to income when received. Subscription income is recognised in the year in which it entitles an organisation to be a member of the WCPT. Income in respect of events, including congress, is recognised in the year to which it applies. Such income is shown in deferred income and is included in creditors.

1.3 Expenditure and liabilities

Liabilities are recognised as expenditure when there is a legal or constructive obligation committing the charity to the expenditure. Expenditure is accounted for on an accruals basis, inclusive of VAT which cannot be recovered. Expenditure on raising funds includes investment management fees.

Overhead and support costs, including staff costs and governance costs, have been allocated to charitable activities on the basis of staff time.

1.4 Pension costs

The group contributes to money purchase schemes. Pension costs payable are charged to the statement of financial activities as incurred.

1.5 Operating lease

There were no operating leases during the period under review.

1.6 Tangible and intangible fixed assets

Individual fixed assets costing £500 or more are capitalised at cost.

Depreciation is provided on all tangible fixed assets at rates calculated to write off the cost on a straight line basis over their expected useful economic lives as follows:

Office furniture and equipment	25% - straight line basis
Computer equipment, software and website	33% - straight line basis
Leasehold improvements	33% - straight line basis

1.7 Investments

Investments are stated at market value at the balance sheet date. The statement of financial activities includes the net gains and losses arising on revaluation and on disposals during the year.

1.8 Funds

Restricted income fund

The restricted fund relates to those amounts which must be spent as income on the particular purposes specified by the donor or else by the terms of a grant or contract. These grants further the work of WCPT and support full participation in WCPT activities. The fund balance includes the Mildred Elson award, for awards to physiotherapists who have contributed significantly to the development of the profession.

Unrestricted income funds

The unrestricted (general) funds may be used at WCPT's discretion, in order to further the charity's objects. These reserves have been built up to safeguard WCPT in the event of unbudgeted expenditure arising as a result of unforeseen circumstances, as well as for recognising costs which would be incurred on a winding-up of WCPT. The trustees may make transfers between the general fund and the restricted fund where appropriate.

There are no designated funds.

1.9 Foreign currencies

Assets and liabilities in foreign currencies are translated into sterling at the rates of exchange ruling at the balance sheet date. Transactions in foreign currencies are translated into sterling at the rate of exchange ruling at the transaction date. Exchange differences are taken into account in the statement of financial activities.

1.10 Financial instruments

Other than forward current contracts, WCPT only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value, with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method. Forward contracts are revalued at fair value at the balance sheet date with gains or losses being allocated to the relevant activity heading in the statement of financial activities.

1.11 Significant estimates and judgements

The trustees do not consider that any significant estimates or judgements have been used in the preparation of these financial statements.

1.12 Congress and subsidiary company

Congress is held regularly in partnership with the host member organisation. A wholly-owned subsidiary company, WCPT Trading Limited, has been incorporated to undertake congress operations. Expenditure on congress incurred by WCPT and the subsidiary is charged to the consolidated profit and loss account for the year. Income received and receivable in respect of the congress after the balance sheet date is treated as deferred income until the event has taken place.

1.13 Related party transactions

The World Physiotherapy group consists of a charity, World Confederation for Physical Therapy, registered at the Charity Commission (234307) and a limited trading company, WCPT Trading Ltd, registered at Companies House (08322671). WCPT Trading Ltd manages congress events on behalf of the World Confederation for Physical Therapy. Any accumulated distributable profits within WCPT Trading Ltd are given as a Gift Aid donation to the charity. The charity supplies staff to WCPT Trading Ltd to support the creation and running of events, and during the year £251,490 (2024: £208,466) was invoiced to recharge for this activity. As at 31 December 2025, WCPT Trading Ltd owed £250,266 to the charity (2024: £604,230).

In July 2023 the members of WCPT agreed to register a new charitable incorporated organisation (“CIO”). This new organisation - World Physiotherapy - was registered on 13 March 2024, under charity number 1207425. The trustee body is the same as WCPT, and it has similar objects. The intention is that once the CIO has been fully set up ready to be operational, WCPT will transfer all its existing assets and undertakings to the CIO. There is no set timetable for the transfer - and the CIO will remain inactive until such time as assets are transferred from WCPT to the CIO.

The CIO was inactive during the period. However, new bank accounts were opened during 2025, and a holding sum of money was transferred to the CIO from WCPT to ensure that the accounts remain operational. As at 31 December 2025, the CIO owed £1,315 to the charity.

There were no related party transactions with the trustees of World Confederation for Physical Therapy; nor with the directors of WCPT Trading Ltd; nor with the trustees of World Physiotherapy (the CIO) - save for the travel and expenses costs shown in note 6.

- The Tajikistan Project is funded by EKFS, to develop a national physiotherapist entry level curriculum in Tajikistan, as well as for developing training materials.

- The Internship Project was funded by the Taiwanese Ministry of Health and Welfare to support two qualified youth participants to undertake an on-site internship, providing observational visits and training under the program.

- The Mildred Elson award is the highest honour that WCPT can bestow. It is for outstanding leadership contributing significantly to the development of physiotherapy internationally.

It was established in 1987 with funds donated by the American Physical Therapy Association and only one Mildred Elson Award is given at the time of each WCPT General Meeting.

These meetings take place every 4 years, and the fund covers the associated travel costs for the award recipient to attend.

- The amounts transferred between funds are to account for general overheads (such as staff costs) which are usually included within the general funds, and which may be allocated to each project in accordance with the conditions of the grant.
