The purpose of this Request for Proposal (RfP) is to engage a suitably qualified and experienced consultant or consultants to assist World Physiotherapy in the following:

(a) The development of World Physiotherapy’s “Physio 2040 Vision Statement”

A long-term aspirational vision describing the desired future global state of:

- the physiotherapy profession and workforce;
- the important role and contribution of physiotherapists within health systems;
- provision and access to high-quality, affordable rehabilitation services; and
- the role of World Physiotherapy as the global professional voice, advocacy and standard-setting body.

(b) The development of World Physiotherapy’s 2027-32 Strategic Plan

A practical and measurable strategic plan that:

- aligns and support progress towards achieving the Physio 2040 Vision;
- identifies strategic priorities;
- defines World Physiotherapy’s organisational objectives;
- establishes SMART actions, outcomes and impacts; and
- provides a framework for monitoring, evaluation and learning.

3. Evaluation/ award criteria

Proposals will be assessed to determine the most economically advantageous tender using the following criteria and weightings:

Evaluation criteria	Weighting
Quality	30%
Methodology and approach	15%
Delivery time	25%
Commercial	30%

Scoring Model

Proposals will be scored by an evaluation panel appointed by World Physiotherapy for all criteria other than Commercial using the following model:

Points	Interpretation
10	Excellent – Overall, the proposal demonstrates that the consultant meets all areas of the requirement and provides all the evidence requested at the level of detail requested. This is a detailed proposal that meets all aspects of the requirement, leaving no ambiguity as to whether the consultant can meet the requirement.
7	Good – Overall the proposal demonstrates that the consultant meets all areas of the requirement and provides all the evidence requested but contains some trivial omissions in relation to the level of detail requested in terms of either the response or the evidence. This is a good proposal that meets all aspects of the requirement with only a trivial level of ambiguity due to the consultant's failure to provide all information at the level of detail requested.
5	Adequate – Overall, the proposal demonstrates that the consultant meets all areas of the requirement, but not all the evidence requested has been provided. This is an adequate proposal, but with some limited ambiguity as to whether the consultant can meet the requirement due to the consultant's failure to provide all the evidence requested.
3	Poor – The proposal does not demonstrate that the consultant meets the requirements in one or more areas. This is a poor proposal with significant ambiguity as to whether the bidder can meet the requirement due to the failure by the bidder to show that it meets one or more areas of the requirement.
0	Unacceptable – The proposal is non-compliant with the requirements of the RfP and/or no proposal has been provided.
